



**Regular Council Meeting Summary
March 3, 2025**

The March 3, 2025, Regular Council Meeting was called to order at 7 PM in Council Chambers at the Town Office in White City. Check out the agenda and meeting recording here:

The meeting included the following items:

Agenda – Council moved that item 8.0 Closed Session be added to the agenda.

Declaration of Conflict of Interest – There were no conflicts of interests declared.

Consent Agenda – The Consent Agenda included minutes of the previous meeting, and ratification of accounts and payroll. The Consent Agenda was accepted after a brief clarification on accounts and payroll.

Town Manager Report – The Town Manager provided Council with updates and insights on several topics, including the WCRM158 Wastewater Authority Improvement Project funding, 2025 SAMA Revaluations, incoming Manager of Finance, R.M. of Edenwold Swimming Pool Feasibility Committee, and concerns regarding coyotes in town. The report also provided some background information regarding Business License requirements and enforcement, and the Saskatchewan Public Safety Agency MBC policy related to motor vehicle collision incident response. Council undertook discussion related to the SAMA Revaluation numbers and the Saskatchewan Public Safety Agency policy update. The report was accepted as presented.

Old Business – Council reviewed the follow item under old business:

- **The Base Tax Bylaw** – Without additional discussion, Council proceeded to third reading and the bylaw was adopted.

New Business – Council reviewed the following items under new business:

- **2024 Tax Enforcement** – Following a report from Administration, Council moved that Administration proceed to acquire title on the properties outlined in the report.
- **Memorial Policy** – Following a brief discussion from Council to clarify the details of what the policy includes, excludes, and its overall impact, the policy was approved.
- **Sewage Pumping Station (SPS) No. 6 Control Panel Replacement** – Administration presented a report to Council regarding the request. During the discussion, Council reviewed the current maintenance procedures for the lift station, including routine inspection processes, ongoing upkeep, and anticipated instances of future infrastructure replacements.

- **Transportation Advisory Committee Terms of Reference Amendment** – Administration presented a recommended amendment to the terms of reference for the Transportation Advisory Committee to adopt a flexible membership to a maximum of eight members to account for fluctuations in qualified applicants, and to further approve the appointment of a new member for a three-year term. Following a short discussion from Council, the amendment was approved.

Roundtable – During the roundtable discussion, Administration and Council provided updates and discussed:

- White Butte RCMP Action Plan information request from the Town.
- Councillor public disclosure forms.
- Success of Chillfest 2025.
- Latest Emerald Park/White City Lions Club meeting.

Closed Session – Council entered a closed session to discuss the Town Manager's Report including, advice, proposals, recommendations, analyses or policy options developed by or for the local authority related to the operations of municipality. Following the closed session, there were no further discussions or decisions.
